This web site is part of the President's Disaster Management Egov Initiative, a larger initiative aimed at greatly enhancing Disaster Management on an interagency and intergovernmental basis. The Disaster Management initiative will make disaster assistance information easier to find, cut the "red tape" for citizens to apply for disaster assistance, and eliminate redundant agency processes. The accelerated provision of information and services to disaster victims will expedite recovery, reduce government spending, speed rebuilding, and restore public confidence.

SBA provides low interest disaster loans to homeowners, renters, businesses of all sizes and private, non-profit organizations to repair or replace real estate, personal property, machinery & equipment, inventory and business assets that have been damaged or destroyed in a declared disaster.

Any business that is located in a declared disaster area and has incurred damage during the disaster may apply for a loan to help repair or replace damaged property to its pre-disaster condition. The SBA makes physical disaster loans of up to \$2.0 million to qualified businesses. Physical Disaster Loans are for permanent rebuilding and replacement of uninsured or underinsured disaster- damaged privately-owned real and/or personal property. SBA's physical disaster loans are available to businesses of all sizes and private, non-profit organizations.

Economic Injury Disaster Loans provide necessary working capital until normal operations resume after a disaster. The law restricts economic injury disaster loans to small businesses, small agricultural cooperatives and certain private, non-profit organizations of all sizes.

Physical Disaster Loans are for permanent rebuilding and replacement of uninsured or underinsured disaster-damaged privately-owned real and/or personal property. SBA's physical disaster loans are available to homeowners and renters.

Preparing for Disasters

Are your home and/or business ready if a disaster strikes? Get information and suggestions on paperless recordkeeping, documenting assets and valuables, and emergency planning.

For Businesses - [IRS Disaster Tax Center](#) Special tax law provisions may help taxpayers and businesses recover financially from the impact of a disaster, especially when the president declares their location to be a major disaster area. Depending on the circumstances, the IRS may grant additional time to file returns and pay taxes. Both individuals and businesses in a presidentially declared disaster area can get a faster refund by claiming losses related to the disaster on the tax return for the previous year, usually by filing an amended return.
